Coffeehouses and the Rise of Science (with [Jens Oehlen](#))

Can social spaces raise knowledge production by lowering the cost of learning from others? Historians have long credited coffeehouses, commercial venues where strangers met across social ranks, with fostering rational debate and seeding Enlightenment culture. We test this claim for science in seventeenth-century London. Using geocoded records and a staggered event study across parishes, we find a substantial and lasting increase in the number of mathematical practitioners and scientific instrument shops following a parish's first coffeehouse. Effects are concentrated among practitioners with weak ties to Oxford and Cambridge, connections between theory-oriented scientists and instrument makers multiply, and new shops turn toward experimental instruments. We argue coffeehouses fostered this growth by cheapening access to scientific knowledge for those outside academic networks and by making experimental science interactive and public.

Learning to Participate: The Effects of the First Female Teachers (with [Mattias Folkestad](#))

How does opening a profession to a previously excluded group shape the next generation? We study women's entry into elementary-school teaching in Sweden after the 1859 reform that first allowed them to hold certified positions. Teaching rapidly feminized, and teachers became overrepresented among the female political elite. We link newly digitized teacher registers and school-district maps to full-count censuses and roughly 350,000 handwritten signatures from the 1913–14 women's suffrage petition. Exploiting the staggered arrival of female teachers across school districts, we find that potentially exposed girls were more likely to participate politically and work in non-domestic occupations as adults. Exposed women were 23 percent more likely to sign the petition and, in 1910, 9 percent more likely to hold a non-domestic occupation. Spatial estimates using access to female teacher seminaries provide evidence linking female teachers to stronger local suffrage support.

Wealth Confiscation and Elite Persistence: Evidence from the Great Reduction (with [Jonatan Riberth](#))

Can wealth confiscation weaken elite persistence? This paper studies Sweden's Great Reduction of 1680, the largest wealth redistribution in Swedish history, in which the Crown confiscated roughly half of noble estates. We link noble genealogies to landholdings from the sixteenth to twentieth centuries across Sweden, Finland, and parts of Russia. Using variation in exposure to confiscation, conditional on observables, we estimate the immediate and intergenerational effects of the Reduction on economic and social outcomes. The shock persistently reduced landed wealth: affected families owned substantially fewer manors than otherwise similar noble families across generations. Yet these losses did not meaningfully alter demographics, military careers, marriage patterns, or human capital. The results show that elite persistence did not rest on wealth alone: confiscation reduced landed wealth for generations, but left other markers of elite status largely unchanged.
